The City Council held a meeting with the members of the Planning and Zoning Board and the Zoning Board of Adjustment to discuss matters of common interest.

Albemarle Non-Residential Building Maintenance Standards

------

The City Manager stated that the Planning and Development Services Director Kevin Robinson is away at a conference and he is handing out a copy of a PowerPoint presentation concerning non-residential building and vacant property maintenance standards for review. Also a handout of proposed ordinance language for board consideration.

The presentation contains the UNC-School of Government recommendations, lists of prioritization scheme for unused, blighted or slightly commercial properties, legal basis for enforcement allowing municipalities to choose what is the best route for the. Also, a chart of prioritization levels showing information on each concerning regulation/order, NCGS authority, statutory standards, recoup costs for the following levels:

> Green – good condition but vacant properties Yellow – vacant, visible deficiencies, but not dangerous properties Red – dangerous properties, but can be repaired Blue/Black – building in need of demolition/removal or urgent care

There was a discussion period and any questions were answered by the City Manager.

## **Discussion: Domestic animals and livestock**

Senior Planner Nasser Rahimzadeh came forward and stated that Sarah Pion came before City Council in early March requesting that the City consider allowing pot belly pegs inside the City limits with whatever restrictions they saw fit. Mr. Rahimzadeh reviewed with the City Council and the Planning Board a chart showing Albemarle, Stanly County and four other cities and if they do/do not allow these type swine and any restrictions that they may have.

The Mayor thanked the Planning and Development Services Department for all their hard work on the commercial maintenance code info and the information from the other cities concerning allowing bot belly pigs inside city limits.
