CALLED MEETING CITY COUNCIL September 17, 2019

The City Council of the City of Albemarle met in a called session on Tuesday, September 17, 2019, at 6:00 p.m. in the Raymond I. Allen Room of City Hall. Mayor G. R. Michael presided, and the following Councilmembers were present, to-wit: Bill Aldridge, Chris Bramlett, Martha Sue Hall, Martha E. Hughes, Shirley Lowder, Dexter Townsend and Chris Whitley. Absent, none.

Mayor Michael called the meeting to order.

The Mayor stated that City Council is hosting this community meeting to hear concerns, questions and ideas about the City having a commercial maintenance code. He stated that the City's Planning and Development Services Director, Kevin Robinson will give a presentation and we will follow with questions from the audience.

Mr. Robinson came forward and gave the following information using PowerPoint. He stated that the City has been working on creating a commercial maintenance code since 2015. This recommendation is a first draft which prioritizes a nuisance versus a structure that is structurally in danger. He has contacted the UNC School of Government and talked with other cities concerning their ordinances.

Non-Residential Building and Vacant Property Maintenance Standards School of Government Recommendations:

- -Include state statutes
- -Prioritize what is "nuisance" vs. what is "structural".... aesthetic vs. hazardous
- -Create a tiered program from vacant, to needing attention, to structurally deficient to requiring possible demolition
- -Provided several model ordinances as well as SOG documents
- -Recommended including a vacant property registry

Repair of Nonresidential Buildings: NC Local Government Authority

-Lists a Green to Red/Blue prioritization scheme for unused, blighted or unsightly commercial properties

- -Provides the legal basis for enforcement
- -Allows municipalities to choose what is the best route.

Staff Changes and Recommendations for Ordinance Amendments

- -Incorporate SOG recommendations
- -Additional Definitions
- -Incorporates additional tools for abatement such as receivership and expands surety option
- -Allow for a comprehensive approach to addressing vacancy, neglect, deterioration and demolition of commercial structures
- -Council can pick what to adopt or adopt it all and allow Staff to prioritize implementation as resources allow.

Green to Red/Blue prioritization scheme categorized:

Green: Good Condition, but vacant

Yellow: Obviously vacant, Visible deficiencies, but not dangerous

Red: Dangerous, but can be repaired

Blue/Black: Building in need of Demolition/Removal or Urgent Care

Non-Residential Building and Vacant Property Maintenance Standards

- -Combines multiple ordinances being used across the state.
- -Comprehensive in scope and used by successful departments across the country
- -Difficult to enforce immediately in its entirety
- -Written to provide flexibility to Staff to begin enforcement step by step rather than adopting piecemeal ordinances.

Mr. Robinson answered any questions that Council or the public had. Also, listened to any concerns, input, or recommendations given by the public attending.
