# TEK Development Easement Agreement

This is the same entity as Earnhardt Exchange LLC, as the owner has changed the name. Back in the November 2, 2020 Council meeting, Council agreed in principal to a sidewalk easement in order for the developer to install window wells which meets code. However, a formal agreement is necessary. The City Attorney has drafted an agreement for an encroachment easement along the side of the building where the wells will be placed.

Upon a motion by Councilmember Dry, seconded by Councilmember Whitley and unanimously carried, Council approved the encroachment agreement as specified above.

# Property Donation from American Legion

At the Carolina Avenue/Don Montgomery Park, there is a free standing building which has served as a concession stand. Due to COVID, American Legion baseball games have not been played as in past years. The American Legion wishes to donate the building to the City of Albemarle.

Upon a motion by Councilmember Aldridge, seconded by Councilmember Dry and unanimously carried, Council authorized the donation of the building from American Legion to the City of Albemarle.
